

Please allow me to take a little of your time to say a few words in favor of the candidacy of Larry J. Gordon for the office of President-Elect of the American Public Health Association. This might seem a bit strange coming from a health educator in Kansas City, Missouri, but I really do speak from a longstanding personal and professional association with Larry.

As a brief self introduction, I was a Health Education Consultant with the Arizona and New Mexico State Health Departments during 1951-59, Director of School Health in New Mexico from 1959-69, and have been Director of Health Education with the Kansas City, Mo. Health Department from 1969-present.

When I first met Larry back in the mid-1950's in New Mexico, we were both relatively young and inexperienced. But even then, everyone at both the State and local levels of the Health Department network there thought of Larry as being a public health professional who was years ahead of his time in his work.

What do I remember most vividly about Larry's capabilities? Let's start with his assets of strong but wise leadership in his jobs and the many organizations to which he has belonged; his broad knowledge and concerns for all aspects of public health; his well-known administrative style and reputation of eliciting the best from his staff and the most from his other available resources — all in a team approach to public health problems; his appreciation of the importance of good communications with everyone; his ability to strategically delegate responsibilities as needed and on the basis of others' known strengths; his dignity, sensitivity, and acute sense of diplomacy which continously enabled him to cope successfully with all kinds of health problems involving a wide divergence and variety of ethnic, cultural, political and professional backgrounds; and last, but not least, his delightful sense of humor, intelligence and perennial optimism.

As a health educator, I also especially remember from personal experiences that Larry was one of the rare public health professionals back in the 1950's who had a true appreciation of the capabilities of trained health educators in regard to planning, evaluating and making subsequent recommendations concerning the educational components of various public health programs, including his own. Again, Larry was a man ahead of his time.

He also helped us in New Mexico to pioneer a successful joint venture between the State Departments of Education and Public Health to go beyond routine inspections of schools at the local level. After these inspections, when major health-related problems were found, efforts were made to locate both State and local resources(expertise, special funding sources, etc.) to assist local school administrators in correcting such problems. This anecdote is cited as one example to help illustrate my personal knowledge that impact, not just amount of effort exerted, is Larry's main criterion for success.

His expertise and outstanding record in environmental health, the many offices he has held, and the many prestigious awards he has received were listed in the last issue of APHA's newsletter "The Nation's Health". In that delineation of qualifications I hope you also noticed that Larry has broad competencies, interests and experiences in the total public health field —not just the environmental aspects. For example, his services to APHA and knowledge of its internal structure and functions are evidenced by his membership (and offices) on such APHA groups as the "Action Board" in 1970-72, Task Force on National Population Policy in 1971-72, the Governing Council from 1974-79, and the Executive Board from 1975-79. His ten years of experience as a Consultant in Comprehensive Health Planning at both the State and local levels in New Mexico and in the U.S. Public Health Service were also strong "pluses" in his favor in maintaining a broad perspective al all health issues.

And then there is the significent fact that he was selected to head New Mexico's state public health agency for the past few years, which speaks for itself concerning the confidence that his professional and political colleagues and supporters have had in Larry's public health knowledge, experience, judgement and leadership capabilities.

Although I left New Mexico in 1969 to come to Kansas City, Larry and I still keep in touch with each other occasionally. We do this as friends and for professional opportunities to exchange information and ideas through various articles we've presented at various places (however his 74 published articles make him a far more prolific writer than I).

In addition to his concerns for the status of public health today, many of Larry's thoughts, ideas and recommended strategies still run well into the future— again, indeed, a man well ahead of his time but with <u>current</u> abilities to help APHA to grow and become even a greater force in shaping the future of public health in this nation.

Therefore, I'm proud to endorse Larry Gordon as a candidate for President-Elect of the American Public Health Association, and ask for your support as a member of the Governing Council in helping him to be elected to that office at the annual APHA meeting in New York on November 7th.

Larry J. Gordon, Director of the Environmental Health and Energy Department for the City of Albuquerque has been awarded the 4th Annual Davis Calvin Wagner Sanitarian Award by the American Academy of Sanitarians.

Mr. Gordon recommended the creation of the nation's first local environmental health department in Albuquerque in the early 50's and became its first Director. He subsequently developed the Metropolitan Environmental Health Advisory Board and recommended creation of the City/County Air Quality Control Board. He was instrumental in the passage of a state statute authorizing municipal health departments and in the passage of the New Mexico Air Quality Control Act, the New Mexico Water Pollution Control Act.

At the state level, as Director of the Environmental Services Division, in the early '70's, Mr. Gordon recommended creation of the Environmental Improvement Division and The Environmental Improvement Board. He visualized and brought to fruition as its first director, the New Mexico Scientific Laboratory System, unique in the nation as the only comprehensive state laboratory which serves a wide variety of local, state, and federal programs on a reimbursment basis. Mr. Gordon later worked to create and subsequently became Deputy Secretary of the New Mexico Health and Environment Department. In this capacity, he adiministered all state

programs of environmental improvement, laboratory services, personal health services and health planning.

In 1982, he returned to Albuquerque as Director of the Environmental Health and Energy Department. He has promoted the development of one of the few municipal hazardous waste programs in the country. He has published the "Guide to the Role of Local Health Officials in the Local Management of Hazardous Waste", a standard work for local communities in the development of their own programs.

Through Mr. Gordon's guidance, New Mexico has local and state environmental health, air quality and environmental improvement advisory and regulatory boards, all of which continue to serve as national models for other state and local governments.

Mr. Gordon has also promoted public and environmental health on the national and international levels as an active member of the 50,000 member American Public Health Association. In 1980, he became the first sanitarian to be elected President of APHA. Throughout his career , Mr. Gordon has been dedicated to environmental health concerns and to the promotion of qualified health professionals.

SUBJECT: Requested Comments on Draft

I sat down last night and reviewed your draft of "The Future of Environmental Health", and I must say that I was very impressed and enthusiastic about the recommendations that you put forth on the cover memo.

In a way, the Committee's report brings back a lot of memories of things that I have been saying ever since I was elected to a Regional Vice President position. In particular I am referring to the concept that this organization, NEHA, must broaden its membership and expertise to include disciplines other than just those programs which are sanitation related. In proposing this idea, Diane Evans and I worked long and hard on revising the membership brochure to where it would not be "negatively attractive" to environmental professionals not directly associated with the traditional environmental health activities. Most of our recommendations were approved, although I still do not feel that we went quite far enough.

As you know, this organization has been supported in a fantastic way by many members who have given their entire lives to the protection of the public's health through environmental health activities. The unfortunate fact of the matter, and one which is stressed in the draft, is that times are changing and the practice of environmental health is evolving at a very rapid rate. And as such, it is incorporating many more fields of interest than just traditional environmental health fields. It is my opinion that the academic sector is trying to address this change, but I don't feel that NEHA's existing membership has fully come to grips with the idea.

Your connection between environmental health and environmental protection is right on the mark. It is time that we realize this and begin to network more with other disciplines such as land-use, transportation, resource development and utilization, as well as economic development. I have been trying to do this in my area for

a good many years, and I must say it is working. We are having more and more instances where we have been asked for our opinion (even by organizations traditionally involved in environmental utilization) and more importantly, have seen our non-binding recommendations used in the development of proposals, both public and private.

I also would agree with your comment that there is no standard organizational model for environmental health and protection programs and agencies. At one time my department had all traditional environmental health programs plus air, water and solid waste. Then due to political pressure, it was decided that the traditional programs were "health related" and should be as a division of the health department and the air, water and solid waste programs were not "health related", and were therefore placed in a Department of Environmental Protection (sounds familiar, doesn't it?). Nevertheless, while seemingly not the best organizational arrangement, we have been making the best of it, even with the fragmentation.

So, as you can see, I am very much in agreement with your report, and you have my complete support. However I would like to suggest that item 21 on page 17 get a little more elaboration. I think this is a very important factor. Environmental organizations and practitioners must be more involved during the planning stages of land-use and similar activities to prevent development in a manner which possibly will have adverse affects on health and the quality of life in the future.

Thank you for the opportunity to review the draft. I look forward to seeing you in Winnipeg.

Mr. Gordon,

Please forgive this intrusion on your valuable time, but I have found that you are one of the few voices of reason in the wilderness of "Public Health". I am looking to you at this time for whatever advice that you can provide me, great or small. However, before I elaborate on the problem at hand, please let me give you some background information which will allow you to understand where I am coming from.

I am Master of Public Health graduating student in the Health Service program at the University of Washington. I also recently earned my doctorate in Medial Sociology and Health Policy from the University of California, San Francisco, where my doctoral thesis was on "The Meaning of Self-Rated Health". I have a fairly extensive background, in social theory, quantitative methods, health policy, and medical sociology, with specialized research in social inequality and health care (You can relax, I am not looking for a job, as I have several offers already.) I am also a member (albeit student) of the American Sociological Association, American Public Health Association and Washington Public Health Association, thus I am fairly aware of the direction that social science and public health are taking.

To be fairly direct, my issue at hand is something you wrote in "The Nation's Health" in December 1989 and November 1992. In it you stated that Public Health had no business being involved in health care and that the APHA's Health Care for All effort is misguided. Moreover, that "Health care is not public health!"; "Public Health is not health care!". And lastly, that "more and more for health care results in less and less for public health (disease prevention, health promotion and environmental health) - health efforts which could have a positive impact on the health status of Americans, as well as slowing spiraling health care costs".

I absolutely, positively, could not agree with you more! However, and here is my real problem, the difficulty is that I can't seem to get anybody to do anything more than provide lip service to this understanding of the truth. In fact, I am currently reading a "The Limits of Social Policy" by Nathan Glazer, which does parallel the precepts you have

stated, so I do know that somebody else is listening, which is a little encouraging.

However I wonder, as someone who fervently believes that we must separate public health and health care, and believes as my mentor S. Leonard Syme (U.C.-Berkeley) stated at the California Public Health Association meeting in 1990, that we must return to the premises of "old" public health: public issues which relate to health prevention, promotion, and environmental health, and not health care, how can I continue to support and operate within an organization such as the APHA which refuses to recognize how misguided it's direction is?

Unfortunately, I seem to find that the vast majority of other public health students, academics and professional that I talk to are firmly invested in National Health Care (my emphasis), rather than concerning ourselves with more legitimate realms of expertise. Moreover, present day public health as taken over the perspective of acute medicine and has become little more than what I refer to as "Medicaid" medicine.

In addition, as you stated in the August 1990 editorial of the AJPH, we have a lack of leadership in the direction of environmental health and other traditional realms of public health.

At any rate, I would truly look forward to knowing more about what you think on the matter, and whether, in the current social and political climate, there is any chance of the APHA getting "back on course". I am very appreciative that you have the courage to take a stand, and state the facts as they truly are, rather than being quiet or jumping on the band-wagon like so many others I find.

That impressed me to the extent that I began to seek out papers you had written and attend, when possible, sessions you were giving or chairing.

It was refreshing to see a sanitarian who was advocating new and better ways to approach the problems of environmental health and was willing to buck trends and take any criticism that might result from such a stand. The long and short of it is that you soon became my ideal. I determined that that is the type of individual I would like to be as it appeared to me to be the most productive way for the long-term good of our profession. Throughout the years, Larry, I must say that you have never disappointed me. Not only have you continued to be the person I wanted to model after, but you have become what I consider to be a close friend. I can't count the times that you have helped me personally by giving me advice or by helping me in the ways you were able to in our professional association.

In the annals of the history of environmental health your name must stand among the very top of persons honored for contributing the most in technical knowledge, program development and unique management techniques. Your thoughtful papers, studies and presentations have served as constant references for

all of us as you have continued to pioneer our field from those early days right up until the time you have announced you were going to retire. Not only have you developed our field but you have developed people and relationships. That accomplishment is perhaps as important for the long-term good of our profession as the technical aspects of the profession itself. It has always been a pleasure to work with you and to fellowship with you. There are few who have influenced my life as much as you have and for that I want to thank you.

In the beginning I indicated a concern over hearing of your retirement. I guess that is natural because when a good leader such as you decides to retire the profession cannot help but suffer. On the other hand, I get the feeling from our recent discussions and what I have heard that perhaps the more accurate term would be that you are leaving one job, however your activity will not cease in the promotion and development of the field of environmental health. I suspect and hope that your influence will continue at least to some degree in the coming years.

As far as I am concerned, and I hope you concur, our friendship will never cease as I hope our fellowship will also endure. You enter your retirement being able to say "I ran a good race and finished strong." I want you to know, Larry, how very much I hope and pray that God will grant you a prosperous, happy and satisfying retirement and will maintain your health so that you can enjoy those things you have looked forward to for so long. Perhaps you will be able to get that boat out of the driveway more often now and for that I am happy for you.

Again, I wish to say "thank you from the very bottom of my heart for all you have done for me individually and our profession as a whole, and for being such a good friend!"

I look forward to our continued involvement and fellowship in the future.
